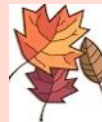

## Message from our President

Even though the League's work continues year-round, September and October are our busiest months in election years. In addition to **two Candidates Forums -- Palo Alto Unified School District Board on September 16 and Palo Alto City Council on September 30** -- we will offer at least four **Pros & Cons** presentations, explaining all the state and local ballot measures.



For other races on the ballot and perhaps more challenging to learn about, the Los Altos/Mountain View League is offering an informal "Meet & Greet" event. **Candidates for Superior Court Judge - Office 24, El Camino Hospital District, Santa Clara Valley Water District - District 7, Foothill DeAnza Community College District and Midpeninsula Open Space District** will be available for your questions. This opportunity will be from **1 to 3 pm on Sunday, September 28**, at the Los Altos Youth Center, 1 N. San Antonio Road, Los Altos. Our League, with help from PTA volunteers, hopes to assist as many Palo Alto schools as possible in conducting a **MyVote California Student Mock Election on Tuesday, October 28**. The Mock Election gives students firsthand experience by providing them a chance to make their voices heard on the candidates and issues on this fall's ballot. The California Secretary of State's office coordinates this excellent introduction to the electoral process for our youth.

A few dates to keep in mind are:

- On **October 6** the Registrar of Voters will begin mailing vote-by-mail ballots,
- **October 20** is the last day to register to vote for the November election, and
- **October 28** is the last day to request a vote-by-mail ballot by mail.

Finally, a bit of good "eco-news." If you would like to "Go Green" for this election, you may choose to receive your Sample Ballot and Voter Information Pamphlet electronically instead of by regular mail. Note that signing up for this service does not enable you to vote online or by e-mail, neither of which is permitted under California law. This environmentally friendly option is only for electronic delivery of your Sample Ballot and Voter Information Pamphlet (SBVIP). 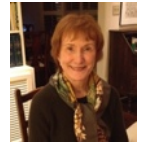


## September Board Meeting Summary

At its September meeting your board took the following actions:

- Accepted the Treasurer's Report and approved the minutes of the August meeting.
- Voted to Support the City of Palo Alto Local Ballot Measure B - Transient Occupancy Tax.
- Voted to Support the City of Palo Alto Local Ballot Measure C - Utility Users Tax.
- Voted to Oppose City of Palo Alto Local Ballot Measure D - Reduce City Council Size from 9 to 7.

- Approved plans for Candidates Forums on September 16 for the Palo Alto Unified School District Board election, and on September 30 for the Palo Alto City Council election as reported by Voter Service Chair **Lovercheck**.
- Adopted a motion to spend additional funds to use three cameras from the Media Center for the City Council forum because of the large number of candidates.

- Approved questions for the candidates for the Santa Clara Valley Water District 7.
- Voted to renew membership in the Palo Alto Chamber of Commerce.



Your board also:

- Discussed general **publicity guidelines** for LWVPA events but also determined that each organizer should make the final decision. There must be continued emphasis on the separation of the League's advocacy events and voters service events so that the public understands this distinction.

Your board learned:

- That Membership Chair **Logan** has formed a committee to discuss and propose suggestions for **increasing membership**, particularly of younger members.
- About **voter registration efforts** at new citizen events, neighborhood events, the Veterans Hospital and Gunn and Paly high schools, as reported by Voter Registration Chair **Taft**.

## The League of Women Voters of Palo Alto Recommends:

### Yes on Measure B: Transient Occupancy Tax.

*To provide funding that cannot be taken away by the State, for general fund infrastructure and City services such as earthquake safe fire stations; pedestrian and bike improvements including safe routes to school, streets, sidewalks, paths, and bridges; and maintaining parks and recreation facilities, shall the City increase the hotel/motel tax by two percent and update language to confirm equal treatment of traditional and online bookings?*

### Yes on Measure C: Utility Users Tax.

*To ensure continued funding for basic and essential services such as police, fire and street maintenance and repair; shall the City of Palo Alto maintain the telecommunications portion of the Utility Users Tax while reducing the rate from 5% to 4.75%; modernize its provisions to ensure equal treatment of taxpayers regardless of telecommunications technology used; and eliminate a discounted tax rate paid by a small number of commercial large users of gas, electric and water services?*

The LWVPA board voted to support these measures based on our LWVPA finance position which reads in part: *The LWVPA supports maintenance of city services and programs at the highest level possible under budget constraints and we support raising reliable revenues as efficiently as necessary to meet these needs.*

These tax measures developed as a result of the work of the Infrastructure Blue Ribbon Commission, established in the fall 2010, which identified the infrastructure needs for all municipal functions except for the City-owned utilities. The Commission and the City Council have reviewed the recommendations, the priorities and the possible funding sources for the last two and one-half years. Both of these ballot measures propose amendments to existing tax ordinances, both modernize the language to include new technologies and both are general fund taxes that can be approved with a majority of the votes cast.

### No on Measure D: Change Council Size to 7.

*Shall the Palo Alto City Charter be amended to change the number of Council Member seats from nine to seven, commencing on January 1, 2019?*

Based on our current position based on 1994 and 2003 studies, the LWVPA board voted to oppose Measure D. The 2003 consensus statement concluded that a nine-member Council allows for more attention to the many obligations of the Council members, including the management of the City's own utilities. A nine-member Council also allows for more diversity, and the length of the meetings depends mostly on the dynamics of how the Council operates rather than on its size.

## The League Of Women Voters of California Recommends:

### Yes on Proposition 2: Rainy Day Fund--State Budget Reserves.

The LWVC supports Prop 2 because it takes an important step toward fiscal discipline in our state government. It requires the state to make contributions to its rainy day reserve fund and pay down debts and liabilities when times are good, with increased contributions in years when revenues spike upwards. In bad times, those reserves can be used to reduce cuts in spending on schools, health care, public safety, and other vital services. Prop 2 requires joint action of the Governor and the Legislature to reduce the amount put in or to take money out of the rainy day fund.

### Yes on Proposition 47: Safe Neighborhoods and Schools Act.

The LWVC supports Prop 47 because it will ensure that prison spending is focused on violent and serious offenses and will maximize alternatives for non-serious, nonviolent crime. The savings generated will be invested in prevention and support programs in K-12 schools, victim services, and mental health and drug treatment.

Prop 47 will change low-level nonviolent crimes such as simple drug possession and petty theft from felonies to misdemeanors; sentences for people convicted of dangerous crimes like rape, murder, and child molestation will not be changed. The League believes alternatives to imprisonment should be explored and utilized, taking into consideration the circumstances and nature of the crime.

### Neutral on Proposition 1: Water Bond

Because League positions do not cover the issues in **Proposition 45** (Healthcare Insurance. Rate Changes), **Proposition 46** (Drug and Alcohol Testing of Doctors, Medical Negligence Lawsuits) and **Proposition 48** (Indian Gaming Compacts), the LWVC is taking no stand on these measures. ### Advocacy Report - Phyllis Cassel

The 2014 **State legislative session** ended quietly and on time, on August 29. The **DISCLOSE Act, SB 52**, passed all its committees and processing steps only to be pulled from the agenda on the last day of the legislative session. It was pulled because of the last minute all out pressure from Labor. Assembly Speaker Atkins and Senators Leno and Hill promise to push hard for this bill next year. There were many amendments to the Political Reform Act of 1974; some 13 League-supported amendments passed, but none of these have the major impact of SB 52 which would make clear who is financing political ads. The Governor has until September 30 to sign the 13 bills that did pass. There were numerous other bills that LWVC supported that also were sent on to the Governor including one that requires health coverage to include all forms of birth control.

## Remembering Mary Elizabeth Van Patten

Mary Elizabeth Van Patten died on August 2 at the age of 94. She was a Life member of LWVPA and remained a LWVPA member even after she moved to San Jose. She was a Kindergarten teacher in PAUSD (retired in 1982) and served on our Board of Directors and our Education Committee. Here are some memories from LWVPA members:

Mary Elizabeth was always a delight to work with.

I remember her fondly.

Mary Elizabeth became hard of hearing (circa 2000) and had trouble hearing at meetings and so taught us something about how to hold a meeting that was open to everyone.

Mary Elizabeth was honored with the Peg Capron Award for Community Service at her church (UUCPA).

Mary Elizabeth was one of the people who advocated for the Palo Alto preschool program a number of years ago.

She was instrumental in persuading Palo Alto to invest in affordable housing.

Mary Elizabeth was such a wonderful example of women who continue to serve their community.

She chaired the LWVPA national study of "Children at Risk" and also served on the Juvenile Justice study committee. She remained as our local "consultant" on issues of children at risk during the time she was on the Board and sometime after.

She was a great advocate for children and resource for education issues.

Mary Elizabeth was a long time participant in our Great Decisions meeting -- always prepared and added much to the discussions. A real loss when she moved to San Jose.

She had an infectious smile and could instantly go from that to seriousness when the discussion changed.

## Women's Equality Day and New Voices for Youth Celebrated at our Summer Social on August 26

**President Ellen Forbes** introduced the Summer Social by reminding us that August 26 was **Women's Equality Day**. She said:

*Ninety-four years ago today -- after decades of tireless advocacy -- the 19th amendment, granting women the right to vote, was signed into law by President Woodrow Wilson. It took a full 41 years of determined work -- at both state and national levels -- to achieve this success.*

***Susan B. Anthony** and **Elizabeth Cady Stanton** had first introduced the amendment in 1878. This historic date honors the culmination of women's suffrage -- but as we know, the fight for universal suffrage continues today.*

Then Bonnie Packer presented a **Resolution** honoring **Mary Alice Thornton's** tireless dedication to LWVPA in all of her varied roles -- too many to list here!

The highlight of the evening was a fantastic program from **New Voices for Youth**, our League youth outreach project, and **YLAC (Youth Leaders About Change)**, a project of YCS (Youth Community Services). **Ana Angel Avendano**, New Voices Project Director, and **Nimsi Garci**, New Voices Intern, presented videos produced by the students in their after-

school program this past spring. **Branessa Kunitz**, facilitator for YLAC, also participated in the Q&A. The **"When Fosters Speak"** video showed the misconceptions that many teens have about foster kids and featured a young woman who is in the foster system.
