On January 25, seventeen members attended **Program Planning** at the home of Alice Smith. The Board gave brief reports on all National, Bay Area, County and City positions, a primer in good government principles. Four members attended **Moderator Training** recently as we prepare our Voter Service work for a June Primary and a November General Election.

## February Board Meeting Summary

At the February Board Meeting your board took the following actions:

- Accepted both the December 2013 and January 2014 minutes as well as the Treasurer's report.
- Unanimously ratified the EAC vote on the Palo Alto Core Values document submitted to the City of Palo Alto.
- Based on the Program Planning meeting in January, voted unanimously to submit to LWVUS two issues for emphasis: citizens' right to vote and campaign finance reform.
- Appointed Pat Saffir to the Budget Committee.



The board also:

- Held a debriefing discussion on the results from the January 29 Program Planning meeting.
- Recommended asking LWVUS to extend the agriculture study update.
- Discussed the successful Bay Area League Day on Open Space held in Oakland on February 1.

The board also learned that:

- There is an off-board vacancy on the Nominating Committee which needs to be filled by a board appointment.
- There has been a decline in membership (237 as of February 4) which will affect the number of representatives we send to National Convention.
- There were 600 LAT letters and *Facts for Voters* mailed.
- There is a need for clerks and callers for LAT (League-a-Thon) for March 10 and 11.
- The February Lunch with the League will be on affordable housing on February 12 with speaker Marlene Prendergast.
- Santa Clara County Leagues are holding a forum on Bay Delta Conservation Plan on March 1 in San Jose.

## Advocacy Report - Phyllis Cassel

LWVPA sent out a Call to Action last month asking each of you to participate as individuals.

**We then composed a letter that we sent to the Council and posted on the City website at "Open City".** See page 5. The statement was drawn from our LWVPA positions and the basic League Principles. ### LWVC

#### **League Charges State with Illegally Denying the Right to Vote to Tens of Thousands of Voters.**

On February 4, The LWVC, the ACLU of California and the Lawyers' Committee for Civil Rights of the San Francisco Bay Area filed the suit in the Alameda County Superior Court. According to the lawsuit the state's actions clearly violated state law when the Secretary of State issued a directive to local elections officials in December 2011 asserting that people are ineligible to vote if they are on post-release community supervision or mandatory supervision. These are two new and innovative forms of community-based supervision created under California's Criminal Justice Realignment Act for people recently incarcerated for low-level, non-violent, non-serious crimes. Court intervention is necessary because a state official should not be able to disenfranchise 60,000 voters with the stroke of a pen. <http://ca.lwv.org/Home> > [Home](#) > [Public Statements](#)

**Legislation: Using Our Updated Initiative Reform Position.** LWVC has been part of an almost year-long process, working with a broad and diverse set of civic and advocacy groups on initiative reform. The process led to a package of changes to the current system that all or most of the groups could agree to. This package is about to be introduced in the legislature, with initial backing from the LWVC and California Common Cause. As the bill progresses through the legislature, some local Leagues may get requests to help lobby for the bill.

#### **Money in Politics Action Alert Coming Up!**

Campaign disclosure bills that LWVC strongly supports are expected to come up for a vote very soon.

- **SB 2** (Lieu and Yee) increases transparency by toughening slate mailer disclosure, requiring state candidates to "Stand by Your Ad" as federal candidates do, and strengthening enforcement.
- **SB 27** (Correa) closes the loophole that allows nonprofits to contribute huge sums in California elections without disclosure.

- **AB 800** (Gordon) gives the Fair Political Practices Commission important tools to investigate suspected violations.

LWVC also supports **SB 52** (Leno), but it is not on the same fast track as the other three bills. You may get messages from the California Clean Money Campaign about SB 52.

### LWVUS

#### **Election Assistance Commission Rejects KS, AZ Request to Change National Voter Registration Form.**

The U.S. Election Assistance Commission (EAC) rejected requests from the states of Arizona and Kansas to modify the national mail-in voter registration form to require voters to provide documentary proof of citizenship with that form. LWVUS joined LWVKS and LWVAZ to submit [comments to the EAC](#) regarding this decision. Read the [press release](#) on this important victory by clicking on this link.

#### **LWVUS Urges U.S. House to Modernize and Repair the Voting Rights Act.**



LWVUS [sent a letter](#) to the U.S. House of Representatives urging them to act quickly on the bi-partisan Voting Rights Amendment Act of 2014 recently introduced by Representatives Sensenbrenner, Conyers, Scott, and Lewis. Members of the League's Lobby Corps will also be visiting targeted offices on the hill to deliver this message in person.

#### **Presidential Commission on Election Administration Issues Solid Recommendations.**

The Presidential Commission on Election Administration (PCEA) released [their report](#) to President Obama outlining **how to improve the administration of America's elections**. In a [press release](#), the League said "there are many good recommendations in the PCEA report and others that we will need to look at more closely to examine the real impact on American voters." We look forward to working with the Commission to implement the best of these recommendations and improve how elections are run across this nation.

#### **Support EPA's Limits on Carbon Pollution.**

President Obama and the Environmental Protection Agency (EPA) have [proposed a first-ever federal carbon pollution standard](#) for every new power plant built in America. This is a game changer for the climate – especially because power plants are our single largest source of carbon pollution. ## **Palo Alto Core Values: LWVPA Statement**

### **Governance**

Palo Alto Governance shall be open and transparent. Meetings, agendas, reports and minutes will be available to all. Each person's ideas will be heard and respected. There will be an open, fair selection of persons serving on boards, commissions, committees and task forces and those persons shall represent a variety of perspectives. Decisions by officials will be made after hearing from many sources, all of which are available to the public. There will be support for the council manager form of government with a mayor elected by the council from among its members.



### **Respect**

Palo Alto citizens, council and professional staff shall treat each other with respect. The interrelatedness of business, commercial and residential land uses will be recognized. The community will strive for a beneficial balance for those uses.

### **Intergovernmental Co-operation**

Palo Alto will support intergovernmental co-operation with other jurisdictions and agencies, such as the school district, the county, neighboring cities and regional agencies. It will have cooperative working relationships with local schools, which provide preschool through college education.

### **Discrimination**

No person will be discriminated against based upon race, color, gender, religion, national origin, age, sexual orientation, or disability. No person shall suffer legal, economic or administrative discrimination.

### **Housing**

Palo Alto will plan for diverse housing options, including persons of all ages, incomes and abilities. We believe that a wide diversity of people in the community increases our understanding and knowledge of the world and improves our decision making.

### **Environment**

Palo Alto will strive to make decisions that will sustain the environment by reducing global warming and using limited natural resources wisely. It will support policies that reduce adverse climate changes and protect our environment. Waste, including toxic waste, will be disposed of in ways that do not harm the environment.

The city will support measures that maximize open space in the foothills west of Foothill Expressway and that maximize open space and minimize development in the Baylands east of Route 101. The city will promote a balance of housing, commercial, services, research and industrial manufacturing in the city.

### **Transportation**

Palo Alto will cooperate on transportation solutions with local and regional agencies. Development will be encouraged to be along the major transportation routes to make maximum use of alternative transportation modes.

## **Lunch with the League Report: Planned Community Zones**

Last month, about 18 folks gathered at Hobee's to hear from our local experts on Planned Community Zones – currently a hot topic in this City.

The panel began with **Senior Assistant City Attorney, Cara Silver**, who explained that a Planned Community Zone (PC) is an Overlay District that supersedes all other categories in the Zoning Ordinance such as Residential, Commercial, or Industrial zones.



To start the PC process **three findings are needed**: the site is situated such that the project and site are not compatible with existing zones; public benefits will be an asset not otherwise possible with regular zoning; and the project is consistent with the Comprehensive Plan and adjacent neighborhoods. The PC process is elaborate and more time-consuming than the normal approval process. The application begins with a hearing at the Planning and Transportation Commission, which is advisory to the City Council. Then the project goes to the Architectural Review Board. It then returns to the Planning and Transportation Commission which must determine that the project meets required findings and has a public benefit. The final step is a hearing before the City Council. All through the review process, issues such as the public benefit, height, daylight plane, parking, and variances from regular zoning are taken into consideration.

**Judith Wasserman, former member of the Architectural Review Board and the Public Art Commission**, noted that the PC Zoning Ordinance is ambiguous. She suggested three solutions: give up PC Zoning as it is not flexible; redefine the public benefits; or clarify the public benefits of the project itself. She concluded by saying, "We [the City] do not sell zoning."

**Phyllis Cassel, former member of the Planning and Transportation Commission and currently a vice president on the LWVPA board,** added that once a PC is passed any major changes to the project require a formal amendment with a complete rehearing of the process. Phyllis reviewed all the PCs since the ordinance was enacted over 40 years ago. Approximately 110 PCs passed, but about 10 of those were redeveloped and rezoned to the underlying zone leaving about 100 PC zones in the City. The first PCs recorded with public benefits were in 1979.

The smallest PCs are 5 single-lot projects that were sold as two-unit condominiums on previous school sites. Only approved PCs are listed and most PC applications are withdrawn if the developer feels it will not get approval, so there is no easy way to determine how many PC applications were not approved over the years.

## Education Committee

The LWVPA Education Committee is growing. We will be having bimonthly meetings at Moldaw Residences. The next meeting will be a luncheon on

**April 3 at noon.** We are also planning to meet with the Santa Clara County Department of Education regarding necessary county needs assessments and the current status of the costs and availability of space for children in the schools.

We are continuing our work on a **Power Point presentation on Early Childhood Education** to be used for education and advocacy. We are in contact with the LWVC Education Committee and are following **SB 837 on Early Childhood Education which is supported by LWVC.** This is the bill that calls for "expanding transitional kindergarten" so that all 4-year-olds will be able to go to preschool.

Regarding the **Higher Education Study**, LWVC board members postponed a vote on the scope of this study as presented by the higher education subgroup committee. They asked for a narrower scope which the subgroup then submitted. The LWVC board will have a phone meeting on February 11 to discuss this further.

The next meeting of the **LWVSCC Education Committee** is on **Monday, March 24, noon** at Grain d'Or, 137 E. El Camino Real at Grant Road, Mountain View.

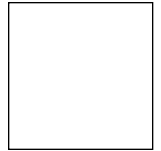
