## Message from our President

The results of the November election have generated in many of us a healthy desire for action. What can our LOCAL League do?



To expand on very good advice: Think globally, think nationally, think statewide, think regionally, think countywide, but **act locally**. To put this advice into the context of the League: support calls to action and educate on issues from LWV United States; LWV California; LWV Bay Area; Leagues of Santa Clara County; and ACT as the Palo Alto League on important local issues.

There has been considerable League action since the election. National continues to work on voter rights and voter suppression issues: [http://forum.lwv.org/sites/default/files/2016\\_end\\_of\\_the\\_year\\_message.pdf](http://forum.lwv.org/sites/default/files/2016_end_of_the_year_message.pdf). National has issued calls to action to halt the repeal of the Affordable Care Act, to contact Congress about the president-elect's conflicts of interest and much, much more. National has also given us sound advice on how to react to the current political situation: <http://lwv.org/blog/10-ways-you-can-help-defend-our-democracy>.

Armed with the LWVUS position on Immigration, the Leagues of Santa Clara County submitted a letter in December supporting the County Supervisors' efforts to provide legal support for undocumented immigrants, which is moving forward, and LWVPA submitted a letter to the Palo Alto City Council in support of a Resolution of Inclusion, which passed unanimously on December 12. Our League co-sponsored an Empathy/Inclusive Community event in December and this month we are publicizing the event: Immigrants and Allies, on January 19 (see page 6) and co-sponsoring a pro-choice event on January 22 (see page 7). Bay Area League Day in San Jose on January 28 is focusing on the regional housing crisis. (See page 3.) We kicked off the new year with an inspiring and exciting Action Brunch on January 7, brilliantly organized by an amazing team led by Megan Swezey Fogarty and Lynne Russell, at Sarah Sands lovely home. Over 80 women and men, including those new to the League, discussed ways we can act effectively to make democracy work. We explored potential action and education regarding affordable housing, transportation, sustainability and climate change, education, sanctuary cities, voter suppression, electoral college, civil liberties and more. Your ideas and your energy will do much to inform our Program Planning process on February 4. (See page 4)

You can direct your energies by becoming active on one of LWVPA's committees: Our Housing and Transportation Committee has been and will continue to be active at the city level on the many housing and transit issues that we expect to be high on our decision makers' agendas. We have an Education Committee that plans to focus on the Palo Alto Unified School District Board, as well as continue its efforts in Early Childhood Education. There are two newly formed committees: one is looking into responsible gun ownership regulations for Palo Alto, and the other is exploring the sanctuary city movement.

This will be the Year of the Rooster. With your commitment we can become a vigorously active League to give the League's virtual rooster something to crow about!

# What is Program Planning?



**On February 4**, all members are encouraged to come together to discuss what should be the League's work for 2017-18 for the local and county Leagues and for 2017-19 for the state League. Your recommendations at this meeting will be voted upon at LWVPA's annual meeting later this spring and at the state convention in June.

**What does Program Planning entail?** The term "Program" in League jargon means: the issues that League members choose at the grassroots level for concerted study, education and action at each League level: Palo Alto/Stanford area, Santa Clara County and, this year, for California. (Next year we discuss the program for the National League.)

Unlike Program Planning in past years, local Leagues are NOT being asked to advise whether the League positions at each level need to be retained, dropped or updated. Rather, we are being asked to focus our energies on deciding issues for emphasis.

**Issues for emphasis** are those issues that our members decide should be the priority for our League, the County Leagues and the State League over the next year or two. Questions to consider when recommending these priority issues for each of these levels include:

- \* Does this issue involve a need not being well met by other groups?
- \* Could the League play a significant role in impacting community concern and/or public policy decisions on this issue? Does it further our long-term vision and impact?
- \* Is there member interest and commitment to this topic?
- \* Is this an issue that would attract participation from the community and our members? Would it entice new members? diverse members?
- \* Do we have the capacity (staff, members/volunteers, funds, project management) to take on this issue? Is it an issue that will attract financial support?
- \* Is this an issue on which legislative or regulatory action is needed? Will political realities permit effective government action during the next one or two years?
- \* If this is a topic for study, will the issue still be timely when the study is completed in several years?

Once members decide on a particular issue for emphasis, **what should the League do?** Where should the League engage? Where can the League make a difference? Where will our League have the most impact? Here are some choices:

- \* Pursue community education about an issue
- \* Advocate on an issue

- \* Study an issue (a traditional study or possibly a concurrence with a position reached by another League or the recommendations of a resource committee)
- \* Consider an update study of an issue on which the League (on any level) already has a position
- \* Consider any combination of these—for example, advocacy on one aspect of an issue while another aspect is being studied or updated; or a combination of action and community education on the same issue

At Program Planning on February 4, to put this effort into context, your board will briefly summarize what actions have been taken at the various League levels over the past year or two. Then we welcome your input on what should be the League's issues for emphasis in the coming year or two. We will also consider the ideas generated at the Action Brunch on January 7.

We look forward to an exciting and important discussion. Thanks for being an involved League member.

## Advocacy Report by Lisa Ratner

### National

#### LWVUS issued a **Call to Action**

for all members to call our senators and congressional representatives to investigate Donald Trump's business dealings which create unconstitutional conflicts of interest, since he has refused to sell his holdings. The LWVUS also asks members to call Congress and tell our representatives to support Elizabeth Warren's bill which would require the President to sell his holdings. **It is not too late for your phone call.** We urge all members to sign up to receive email notifications of calls to action at this link: <http://lwv.org/get-involved>.



Despite valiant efforts by LWVUS and other plaintiffs to head off **voter suppression** using the federal courts, thousands of otherwise eligible voters did not get a chance to cast their votes in the November election because of voter ID laws, purges of voter lists, and reduced precinct resources. ### Local

**Housing Impact Fees.** Our Housing and Transportation Committee continues to follow the city's proposed housing impact fee, which would levy a fee on residential, commercial and office development at a level far above surrounding cities. We have sent a letter opposing such a drastic upward fee, questioning whether it would simply discourage the building of more affordable housing. We also sent a letter on November 30 to the Planning and

**VTA Bus Service.** We continue to follow the VTA's proposed plan for bus service in the County. The current proposal would cut service in Palo Alto, with obvious painful impacts on residents of senior housing and affordable housing facilities which lie on the existing bus routes. The rationale for the cuts is that VTA money is best spent on more heavily used, more frequent routes. Although the VTA claims it might continue paratransit service even if the routes are cut, public pressure is required to make sure this problem is fairly solved. The VTA will hold a public hearing on January 19 at 6 pm at the Palo Alto City Council chambers for comments on the plan.

**Stormwater Fee Increase.** LWVPA has been asked to support the upcoming city stormwater fee ballot measure coming in April 2017. Current fees will expire in June 2017, leaving insufficient money to fund needed storm drain infrastructure and green water conservation measures. We have reviewed the reports documenting the need for the increase and will be reporting to the Board soon on this issue.

#### **Immigration and Civil Rights.**

LWVPA supported Councilman Wohlbach's resolution of inclusiveness brought before the Palo Alto City Council on December 12. We are also working on a potential amendment to the Police Policy Manual which would align city policy with the California Trust Act. This act forbids county and state law enforcement from direct cooperation in immigration enforcement actions absent probable cause, a warrant, or a serious criminal offense. A community meeting sponsored by the City of Palo Alto and many civic organizations will discuss Immigrants and Allies at 7 pm on January 19 in the Auditorium at Cubberley Theatre. The topics will include immigrants' rights and our community response. (See page 6.)

## New Voices (NV4Y) Update



New Voices For Youth (NV4Y) is an after school program for youth in Redwood City, Belle Haven and East Palo Alto designed to encourage civic engagement through video production. It was founded by the Leagues of Palo Alto and South San Mateo in 2004. For more information see: <http://www.newvoicesforyouth.org>.

*New Voices'* new project director, Jose 'Lalo' Saavedra, is rapidly learning our program while leading the middle-school students in our ongoing classes at the Siena Youth Center. Most of the students are new to New Voices and Lalo reports that he has given them freedom to develop individual pieces but that all of them are talking about the gentrification of Redwood City in some way.

At the same time, our team is actively exploring opportunities to reach East Palo Alto and Belle Haven middle-school students with "M-A Speaks Out: The Truth About College" video created by our Menlo-Atherton (M-A) students last spring. This short film expresses "what we wished we'd known before going to high school" and was designed for students, teachers and parents in this middle-school community.

Recently, Dr. Anna Waring, Executive Director of the Foundation for a College Education, and our NV team explored ways our two programs might work together to reach our target audience while enhancing their students' experience. Going forward, Lalo and FCE's Associate Director of Programs, Asra Hussain, will meet in January to further plan their strategy. We are cautiously hopeful that this will lead to a fruitful collaboration for more students.

NV is very pleased to welcome three new members of our League Steering Committee. We are recruiting more members of the committee from LWV Palo Alto. The Committee meets monthly and committee members may participate with as much time as they would like. No commitments are necessary. Contact Veronica Tincher if you're interested.

This year we are continuing to work at Siena, taking a break from M-A and, building on our success at Siena, looking forward to working with middle-schoolers in afterschool programs in Belle Haven and East Palo Alto. Lalo will be finding new partners and figuring out how to use the video that students made at M-A last spring. It promises to be an exciting year for New Voices. We are eager to bring new members into our Steering Committee. Please call Veronica Tincher if you are interested.
