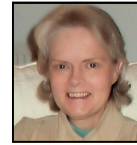


President's Message

It's the economy stupid, is Clinton's message, which means the budget, which means money, which determines staffing. Nothing happens without staffing. And that is where we are with the Santa Clara County Redistricting Commission. Work to support the eleven volunteer commissioners is being absorbed by the appropriate departments, county manager, planning and attorney offices. There is no dedicated budget for the commission. The LWV Santa Clara Council thought we had a transparency issue. The staff report prior to meetings two and three were not on-line. They were not available for the public. We sent a letter expressing our concern. But the issue was not purely transparency. Prior to the meeting there was no staff report for anyone, including the Commissioners. The staff was so busy with other tasks that they did not have time to construct, in a timely manner, the maps that the commission needed. The commissioners were working unprepared. While the draft maps were available at the meeting, it takes no more time to prepare the maps three business days before the meeting than it does to make them the day of the meeting. There are, however, many demands with limited staffing. Money is more than tight. Is the redistricting process more important than housing people, or feeding people, or representing them in court? These are painful decisions we are making. When you receive this *VOTER*, the draft maps should be on the County website (<http://www.sccgov.org>) under *Hot item, NEW! Citizens Redistricting Commission*. I assure you that your League is watching to see that the draft maps and reports are available to all in a timely fashion.

Speaking of timely, call the office immediately to tell us that you are coming to the annual meeting. WE NEED YOU! And we need to have seats and continental breakfast ready for you.

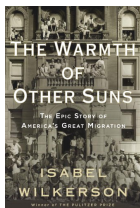

Action

Palo Alto Housing Element: A representative of the LWV Palo Alto spoke at the Housing and Transportation Commission meeting on March 23. We thanked the Commission for making improvements that we had recommended previously, urged the inclusion of other items that we recommended and asked them to move more rapidly to conclude this long overdue housing element.

Santa Clara County Redistricting Commission: The commission determines the five new district boundaries for the Board of Supervisors. The County grew 5.9% from 2000 to 2010, proportionately more in south and west county than elsewhere. The median size of the new districts will be 356,328 persons. There can be no more than a 10% deviation from the smallest district to the largest. A 1% difference is only 3,563 persons. The current districts meet the population requirements. Other requirements are to keep communities of interest together and no gerrymandering. In Santa Clara County all cities are in one district except Sunnyvale at 140,000 persons and San Jose at 946,000. Sunnyvale, currently split between districts 5 and 3, is requesting to be placed in just one district. Two draft maps have been developed to comply with this request. Such a change will require major shifts in district boundary lines. A letter requesting more transparency in the process was sent by the LWVs Santa Clara County Council.

Highlights of the March 22, 2011 meeting

Issues that determine Palo Alto Baylands' future

Flood Control Issues in the Baylands Joe Teresi, Senior Engineer with the City of Palo Alto

Floodplains in the City of Palo Alto were first mapped by FEMA in 1980. The maps designate Special Flood Hazard Areas, which are subject to flooding in a 1% (100-year) flood event. There are currently 2100 Palo Alto properties subject to creek flooding, 1500 properties subject to tidal flooding, and 1200 subject to both flood risks.

One primary flooding source is our local creeks. Matadero, Barron, and Adobe Creeks have been channelized and improved by the Santa Clara Valley Water District, and they now have the capacity to contain the 100-year flood flows without overtopping. San Francisquito Creek, however, still remains a flood risk. The San Francisquito Creek Joint Powers Authority (JPA), US Army Corps of Engineers, and the Water District are currently studying flood control alternatives for the creek. Construction of the first phase of flood control improvements downstream of Highway 101 is scheduled to commence in 2012.

San Francisco Bay is another flooding source affecting Palo Alto. Many of the eastern neighborhoods of Palo Alto are lower than the high tide level. A system of Bayfront levees keeps the Bay from inundating low-lying areas of the city during high tide, but it does not meet FEMA standards for height or stability. The risk of tidal flooding will increase in the future due to expected sea level rise. Experts predict sea level rise increases of 23-27 inches by 2070, and 40-55 inches by 2100. Currently, both the US Army Corps of Engineers and the Water District are studying the tidal flooding issue. No specific levee improvement projects have been identified or scheduled at this time.

Portions of Palo Alto are already below regular high tide levels, and the risk of tidal flooding will increase in the future due to global warming and associated sea level rise.

The City plans to take control of the airport before the end of the lease in 2017 because the County has not been maintaining it, but has been milking it for revenue to pay for other airports.

Palo Alto Airport Ownership Steve Emslie, Deputy City Manager

In 1954, the airport moved to its present location in the Baylands. In 1962, the city entered into a 55-year contract with Santa Clara County, under which the county would operate the airport.

Presently, 500 airplanes are based in Palo Alto, a high number for its size.

A Citizens Task Force

looked into the city operating the airport and decided that it was feasible and the Council concurred. The Business Plan was completed last year and found that the airport could be a money maker. Even though this is a highly desired area, the airport is aging and requires improvements.

There are incentives to take control of the airport before 2017. The County has not been maintaining the airport, but has been milking revenue from the airport to pay for other airports in the county. For example, the county charges a fuel tax of \$0.20 a gallon. Compare that to \$0.05 that the county taxes gasoline for your car.

The city has little choice in keeping the airport open. The city accepted a grant from the FAA to upgrade the airport under the condition that the airport remain for 20 years.

Wastewater Long Range Facilities Planning Brad Eggleston, Manager, Environmental Control Programs

The Plant, which was built in 1970, is the largest energy user in the city.

The Master Plan is a two-year process to overhaul the Plant beginning September 2010. It has a 50-year time horizon. The end result will be a facilities plan of how and when to replace aging equipment and to minimize energy usage. Presently, the Plant, which was built in 1970, is the largest energy user in the city.

Key Issues of Wastewater Master Plan Consideration

- **Biosolids**- The incinerator is close to the end of its useful life. The resulting ash from the incinerator is trucked to a landfill in the Central Valley. The best choice for replacement is a wet anaerobic digester. One future pathway to generate energy may be to combine food waste with biosolids.
- **Recycled water** – Leaky sewer lines increase the salinity of recycled water. This needs a solution. Presently recycled water is limited to the golf course and the Baylands in Mountain View, areas which are tolerant of salt.
- **Nutrient removal** - Nutrients are going to the Bay. Because of the problems this creates, such as algae growth, nitrogen may need to be removed.
- **Energy use** – This needs to be reduced.
- **Pharmaceuticals** are not completely removed by current treatment and pose a hazard to the environment.
- **Sea level rise** – This could impact the Plant’s out-fall. Could sea level rise cause effluent to flow back into the Treatment Plant?

Dry Anaerobic Digestion
Peter Drekmeier,
former Mayor of the City of Palo Alto

The Final Analysis of this plan to compost yard trimming, food wastes, and biosolids is expected in June 2011.

The present composting operation will cease in 2012 and compost will be sent 54 miles to Kettleman City. This amounts to 21,000 tons trucked a year. A Blue Ribbon Com-

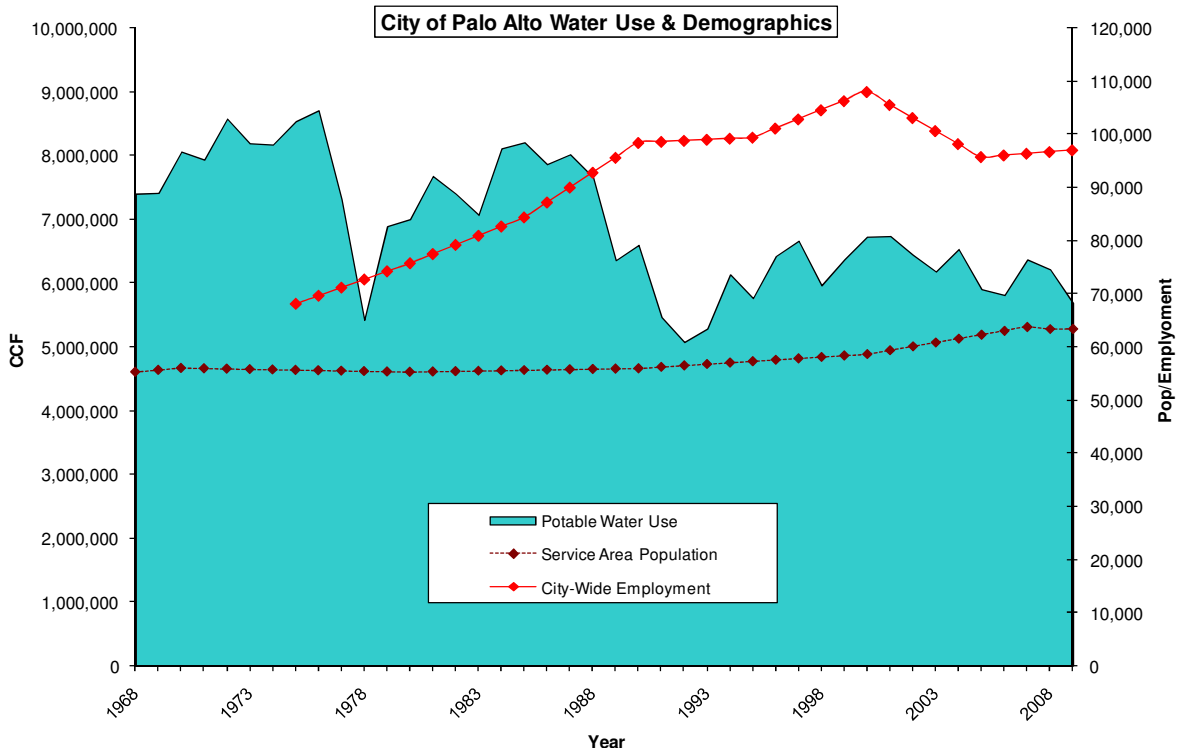
posting Task Force established by the City recommended a dry anaerobic digester as a more environmentally sound solution. The City commissioned a study and the Preliminary Analysis was released on March 21, 2011.

One plan is to generate energy from food wastes and biosolids with an anaerobic digester at the Water Treatment Plant, then send the treated wastes along with yard trimmings to the dry anaerobic digester. The Final Analysis is expected in June 2011.

Palo Alto Water Management Plan

Water consumption has decreased in Palo Alto over the last 20 years, despite the increase in employment and population. Even though there’s no drought in the foreseeable future, water rates may go up to help for pay the \$4.6 billion Water System Improvement Program to *Hetch Hetchy's* aging infrastructure and other projects.

History of the Palo Alto Landfill Emily Renzel, Former City Councilmember

A few points covered by this interesting history include that land-filling in the Baylands formally started in the 1930s and the land-fill was dedicated as parkland in 1965. It was intended to be closed in 1968. The development of a Baylands Master Plan, the need for alternative solid waste disposal sites and successful diversion of solid waste resulted in a series of closure delays. To add more waste the height was increased, valleys filled. Phase I of Byxbee Park opened in 1991. The Sunnyvale Smart station opened in 1992 to receive curbside waste. Phase IIa and IIb of Byxbee park should open this year and Phase IIc the active land fill should close in 2012.

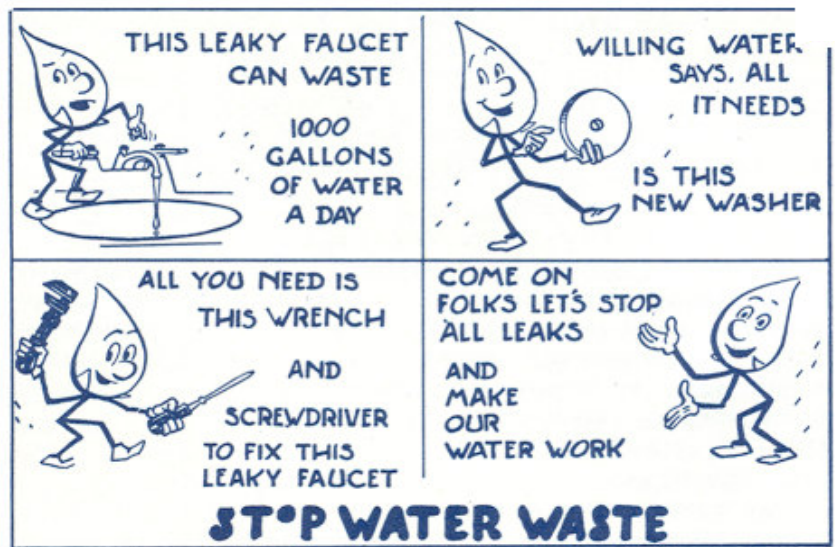
